This fee covers book rentals, workbooks, instructional supplies, standardized testing materials and evaluation, some supplies for art, music, p.e., etc. \*\*Note—you will not be asked for money for Spanish, music, computer, art—these fees are included in the increase. You may still be asked to purchase notebooks, assignment tablets, pens, pencils, etc. for personal use.

**THREE FULL-DAY FOUR-YEAR-OLD PROGRAM: MON., WED., FRI., 8:15 – 2:45**

To enter this program, the child must be at least 4 years old on or before August 31<sup>st</sup> in the year of enrollment. \*\*Enrollment is limited to 6 children.

**\$40.00 Processing Fee—All New Students, due with registration form**

**\$80.00 Non-Refundable Registration Fee due upon acceptance**

**\$200.00 Annual Activity/Snack/Supply Fee per child, due and payable in full on July 15<sup>th</sup>**

**\$15.00 Annual Family & School Association Dues, payable on July 15<sup>th</sup>**

**\$240.00 Tuition per month, due on or before the 1<sup>st</sup> day of each month, August – May**

**Fundraising Fee (per family) \$200.00**

Due in two installments, October 15<sup>th</sup> and April 15<sup>th</sup>, or raised in profits through school fundraising efforts (the difference between profits raised and the fundraising fee will be due April 15<sup>th</sup>). Any additional profits raised go to the general support of the school.

**FIVE FULL-DAY FOUR-YEAR-OLD PROGRAM: 8:15 – 2:45**

To enter this program, the child must be at least 4 years old on or before August 31<sup>st</sup> in the year of enrollment. Enrollment is limited to 15 children.

**\$80.00 Non-Refundable Registration Fee due upon acceptance**

**\$200.00 Annual Activity/Snack/Supply Fee per child, due and payable in full on July 15<sup>th</sup>**

**\$15.00 Annual Family & School Association Dues, payable on July 15<sup>th</sup>**

**\$385.00 Tuition per month, due on or before the 1<sup>st</sup> day of each month, August – May**

**Fundraising Fee (per family) \$200.00**

We ask that all payments (tuition, fees, Before- and After-School payments, lunch money, picture money, money from fundraising) be made promptly. Due dates are always clearly indicated for each fee and activity. If you have any questions about a due date, please contact the school office for information. **If temporary alternative payment arrangements need to be made because of unexpected circumstances, it is critical that the school or parish office be contacted immediately.** If special arrangements are **not** made, payments not received within one month of due date will be assessed a 5% late fee each month until they are paid. If payment is not made for 3 consecutive months, we may regretfully request that the child withdraw until all financial obligations have been met. In addition, all account balances must be current by the last day of the school year or the last day of a child's attendance, or grades and school records may not be released.

Please—help us meet our financial obligations and keep our families' costs from continuing to escalate by adhering to this financial policy. Participation in FACTS provides an excellent method for remaining financially current. Please contact Mrs. Bradley in the Parish Office for more information. All families who wish to make monthly payments are asked to participate in the FACTS Tuition management program.
